CERTIFICATE OF INSURANCE

THIS IS TO CERTIFY THAT as Insurance Brokers we have arranged Aircraft Hull All Risks, Hull and Liability War Risks, Third Party, Passenger, Passenger Baggage, Cargo, Freight, Mail Legal Liability Insurance in respect of the aircraft detailed below:

INSURED:	Alto Aerospace Limited and/or subsidiary companies, employees, directors or their contractors for their respective rights and interest.
AIRCRAFT:	Beech Kingair 200 Registration G-CEGP is covered for the following uses Commercial (including medical services) plus test / trial flights and the continuation of permitted pilots.
AGREED VALUE:	USD 1,200,000 Spares: GBP 200,000 any one building and/or location and/or sending
INSURERS:	Underwriters at Lloyd's and Certain Insurance Companies in London.
POLICY NUMBER:	AV2000992
PERIOD OF INSURANCE:	4th February, 2020 to the 3rd February, 2021 both days inclusive as at local standard time at the address of the Insured.
Combined Single Limit:	GBP 12,500,000 any one accident/unlimited during the policy period
War Risks (subject AVN 52E)	GBP 12,500,000 any one occurrence and in the annual aggregate.

Geographical Limits

Worldwide subject to Kiln Geographical Exclusion Clause LSW 617H as below.

Notwithstanding any provisions to the contrary and subject to clauses 2 and 3 below, this Policy excludes any loss, damage or expense howsoever occurring within the geographical limits of any of the following countries and regions:

- (a) Algeria, Burundi, Far North Region of Cameroon, Central African Republic, Democratic Republic of Congo, Ethiopia, Kenya, Mali, Mauritania, Nigeria, Somalia, The Republic of Sudan, South Sudan.
- (b) Colombia, Peru.
- (c) Afghanistan, Jammu & Kashmir, North Korea, Pakistan.
- (d) Abkhazia, Donetsk & Lugansk regions of Ukraine, Nagorno-Karabakh, North Caucasian Federal District, South Ossetia.
- (e) Iran, Iraq, Lebanon, Libya, North Sinai Province of Egypt (including Taba International Airport), Syria, Yemen.
- (f) Any country where the operation of the insured Aircraft is in breach of United Nations sanctions.

2. However coverage pursuant to this Policy is granted:

- (a) for the overflight of any excluded country where the flight is within an internationally recognised air corridor and is performed in accordance with I.C.A.O. recommendations; or
- (b) in circumstances where an insured Aircraft has landed in an excluded country as a direct consequence and exclusively as a result of force majeure.

3. Any excluded country may be covered by underwriters at terms to be agreed by the Slip Leader only prior to flight.


